TAX LEVY ORDINANCE
ORDINANCE NO. 2022- **350**

AN ORDINANCE OF THE BOROUGH OF **BERNVILLE**
County of **Berks**, Commonwealth of Pennsylvania, fixing the tax rate for the year 2023

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the
Borough Council of the Borough of **Bernville**
County of **Berks**, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the Borough of Bernville subject to taxation for the fiscal year 2022 as follows:

- For **debt purposes**, the sum of mills
on each dollar of assessed valuation, or the sum of cents
on each one hundred dollars of assessed valuation.
- For **street improvement purposes**, the sum of mills
on each dollar of assessed valuation, or the sum of cents
on each one hundred dollars of assessed valuation.
- For **Earned Income- nonresident**, the sum of 1.0 percent
on each dollar of assessed valuation.
- For **Earned Income- resident**, the sum of 0.5 percent
on each dollar of assessed valuation.
- For **local services tax**, the sum of 52.00 dollars
- For **per capita tax**, the sum of 5.00 dollars
- For **real estate – general purposes**, the sum of 5.69 mills
on each dollar of assessed valuation, or the sum of 56.9 cents
on each one hundred dollars of assessed valuation.
- For **realty transfer tax**, the sum of 0.5 percent
on each dollar of assessed valuation.
- For _____ purposes, the sum of mills
on each dollar of assessed valuation, or the sum of cents
on each one hundred dollars of assessed valuation.
- For _____ purposes, the sum of mills
on each dollar of assessed valuation, or the sum of cents
on each one hundred dollars of assessed valuation.
