VEHICLE CONDITION: The vehicle is being sold **AS IS, WHERE IS, with all faults and without warranty**, expressed or implied. The Borough makes no representations or warranties regarding the condition, mechanical operation, or fitness of the vehicle for any particular purpose.

POLICE EQUIPMENT & MARKINGS: Prior to the transfer of vehicle ownership to any non law-enforcement buyer, the Borough shall completely remove and retain all emergency warning lights, strobe systems, and audible sirens. Any remaining exterior police decals, department insignias, or official lettering may be removed at the Borough's sole discretion prior to transfer. All other installed interior utility equipment shall remain with the vehicle and transfer to the successful bidder.

PAYMENT & REMOVAL: The successful bidder must make full payment within 7 business days of official notification of award. Payment must be made via certified check or cashier's check payable to the "Borough of Bernville". The vehicle must be removed within 10 days of finalizing payment.

RESERVATION OF RIGHTS: The Borough of Bernville reserves the right to **reject any and all bids**, to waive any informalities in the bidding process, and to award the vehicle to the highest responsible bidder as determined by Borough Council.
